Work Experience

ATtherapy – February 2021 - Present

Specialist Speech and Language Therapist

In this position I support individuals with complex communication needs associated with a neurological disability. I have a particular passion for the development and use of alternative and augmentative communication (AAC) systems. I also support individuals who have eating, drinking and swallowing impairments.

North Tees and Hartlepool NHS Foundation Trust - November 2017 - December 2020

Specialist Speech and Language Therapist

In this position I provided assessment and intervention to children and young adults with complex communication needs. This included children with physical, medical, learning and/or sensory difficulties and children with Autism Spectrum Conditions. Skills targeted were expressive and receptive language, speech sound difficulties, social communication, eating, drinking and swallowing, and AAC systems. I worked jointly with the parents/carers and the team around the child to identify goals and deliver care plans. I made onward referrals and worked collaboratively with other professionals or specialist agencies, for example the Regional Communication Aids Service. I completed comprehensive written reports including mealtime management plans and contributed to the development and review of Education Health Care Plans. In this position I developed a practical understanding of Quality First Teaching, The SEND Reforms (2014) and SEND code of practice.

I provided assessment and therapy to children and adults who had communication difficulties and/or eating, drinking and swallowing difficulties associated with a brain injury.
